Qualified applicants could receive up to \$9,500 to replace their existing cars with newer, cleaner vehicles or other clean modes of transportation (such as transit passes or car-sharing).

Are You Eligible?

If you answer “Yes” to all of the questions below, you may be eligible for funding.

- Is your annual household income within the ranges listed?
- Do you own your vehicle?
- Do you reside within the South Coast Air Basin or Coachella Valley?
- Has your vehicle been operating in California for the past two years?

- Complete an online application form:
 - Visit the Replace Your Ride website at www.replaceyourride.com
- Required Documents:
 - Copy of a Government issued photo ID
 - Proof of residence
 - Income documentation
 - Copy of vehicle title
 - Documentation showing vehicle operation in California over the past two years
 - Emission test results (a recent Smog Check test, if available)
 - Or, an assigned Case Manager will assist you with obtaining a free vehicle emissions test.
